ISO 9001 IS A GLOBAL STANDARD FOR QUALITY MANAGEMENT SYSTEMS (QMS) THAT HELPS ORGANIZATIONS MEET CUSTOMER AND REGULATORY EXPECTATIONS

ISO 14001:2015

ISO 14001 IS AN INTERNATIONAL STANDARD FOR **DESIGNING AND IMPLEMENTING AN ENVIRONMENTAL MANAGEMENT** SYSTEM(EMS).ISO 14001 REQUIREMENTS **PROVIDE A FRAMEWORK** AND GUIDELINES FOR **CREATING YOUR ENVIRONMENTAL MANAGEMENT SYSTEM** SO THAT YOU DO NOT MISS IMPORTANT **ELEMENTS NEEDED FOR AN EMS TO BE** SUCCESSFUL.

ISO 45001:2018

AN INITIAL ASSESSMENT WILL BE CONDUCTED FOR INITIAL CERTIFICATIONS WHERE WE DETERMINE NON-CONFORMITIES AND WEAKNESSES

STAGE 1

FOR ORGANIZATIONS UNDERGOING THEIR INITIAL AUDIT

AN INITIAL CHECK PRIOR TO THE CONDUCT OF THE ACTUAL AUDIT WHERE WE IDENTIFY CAUSES FOR CONCERN.

STAGE 2

A FULL AUDIT OF YOUR ORGANIZATION AND HOW IT MEETS THE REQUIREMENTS OF THE RELEVANT STANDARD(S)

THE AUDIT DEPENDS ON THE SIZE OF THE ORGANIZATION, COMPLEXITY OF PROCESSES AND THE TYPE OF BUSINESS YOU ARE ENGAGED IN.

CERTIFICATION

PASSING THE AUDIT LEADS TO CERTIFICATION

YOU MAY NOW USE OUR CERTIFICATION MARKS TO DISPLAY YOUR ONGOING COMPLIANCE, PLEASE SEE THE USE OF MARKS GUIDE THAT WILL BE SENT TO YOU ALONG WITH THE CONFIRMATION THAT YOU PASSED THE CERTIFICATION.

CERTIFICATION ACTIVITIES

THE CERTIFICATE YOU HOLD, WHILE VALID AND CONSIDERED ACTIVE, IS SUBJECT TO SURVEILLANCE FOR US TO ENSURE CONTINUING COMPLIANCE.

THIS WILL SUBJECT YOU TO ANOTHER CYCLE OF AUDITS, MINUS THE STAGE 1 AUDIT INTENDED FOR INITIAL CERTIFICATIONS. **SURVEILLANCE AUDITS**

ANNUAL MONITORING OF COMPLIANCE TO THE STANDARD.

RENEWAL

WHEN YOUR CERTIFICATION IS CLOSE TO EXPIRY, A RENEWAL AUDIT WILL BE OFFERED FOR THE CONTINUANCE OF OUR SERVICES AND YOUR CERTIFICATION.

YOUR AUDITOR WILL BE THE INITIAL SCREEN TO DETERMINE YOUR CERTIFICATION STATUS.

WHEN CERTIFICATION IS NOT GRANTED, THE AUDITEE MAY APPEAL AS MENTIONED BEFORE.

THE AUDITEE MAY ALSO REQUEST FOR A SPECIAL AUDIT OR RESTORATION SHOULD THE CERTIFICATION BE SUSPENDED.

A STAGE 2 AUDIT WILL BE CONDUCTED IF RESTORATION IS REQUESTED.

DISCONTINUE THE USE OF PROMOTIONAL ITEMS AND CERTIFICATION MARKS REFERRING TO THE WITHDRAWN CERTIFICATE. DO NOT CONDUCT BUSINESS TRANSACTIONS BASED ON THE CERTIFICATION

GRANT, MAINTAINANCE, SUSPENSION AND REFUSAL OF CERTIFICATION

WHEN AN AUDITEE PASSES AUDITS, WHETHER WITH MINOR NON-CONFORMANCES, OBSERVATIONS OR WITH NO FINDINGS, CERTIFICATION IS GRANTED OR MAINTANED.

CERTIFICATION MAY BE REFUSED OR SUSPENDED IF THE AUDITEE PERSISTENTLY AND CONSIDERABLY FAILS TO MEET THE STANDARD'S REQUIREMENTS, DOES NOT ALLOW FOR A SURVEILLANCE, OR VOLUNTEERS FOR SUSPENSION.

RESTORATION

AN EXPIRED/SUSPENDED CERTIFICATION CAN BE RESTORED WITHIN 6 MONTHS PROVIDED THAT THE OUTSTANDING RECERTIFICATION ACTIVITIES ARE COMPLETED.

FAILURE TO ADDRESS ISSUES THAT LED TO SUSPENSION WITHIN THE 6-MONTH TIMEFRAME CAN LEAD TO WITHDRAWAL OF CERTIFICATION.
